

1 A YES.

2 Q WILL YOU TELL THE COURT YOUR PARTICIPATION, IF ANY, IN
3 ANY SPORTS OR ATHLETICS?

4 A AT THE PRESENT TIME, I TRY TO RUN EVERY NIGHT AND ALSO I
5 PLAY TENNIS, RACQUETBALL, AND WHEN I USED TO WORK IN NEWPORT
6 BEACH, I BELONGED TO A TENNIS CLUB.

7 Q ALL RIGHT. NOW DO YOU FEEL THAT THAT IS IN VIOLATION OR
8 IN OPPOSITION TO ANY TEACHING OF THE CHURCH?

9 A NO.

10 Q ALL RIGHT. HOW ABOUT THE YOUNG PEOPLE, FROM YOUR OBSERV-
11 ANCE OF THEM, THE ONES THAT YOU HAVE SOME CONNECTION WITH?
12 WHAT ARE THEIR ACTIVITIES REGARDING SPORTS OR ATHLETICS?

13 A WELL, I COULD GIVE YOU JUST ONE RECENT EXAMPLE. ON
14 MEMORIAL DAY, WE ALL HAD A PICNIC, AND WE HAVE A GAME OF VOLLEY-
15 BALL, A GAME OF SOFTBALL TOGETHER.

16 Q ALL RIGHT. AND AGAIN, WAS THERE ANY FEELINGS THAT THIS
17 IN SOME WAY WAS GOING AGAINST ANY TEACHING OF THE LOCAL CHURCH?

18 A NO.

19 Q WILL YOU TELL THE COURT WHAT YOUR OWN PARTICULAR PRACTICES
20 ARE REGARDING TELEVISION, THE NEWAPAPERS, AND THE MOVES?

21 A WELL, IN THE BANKING PROFESSION, WE BANKERS HAVE TO BE
22 MORE OR LESS A GENIUS BECAUSE WE RUN INTO MANUFACTURERS,
23 DISTRIBUTORS, HIGH-TECHS, PEOPLE, AND WE HAVE TO KNOW WHAT IS
24 GOING ON WITH TODAY'S TECHNOLOGY AS FAR AS MANY PROFESSIONS. SO
25 WE TRY TO KEEP UP WITH ALL THE THINGS THAT ARE GOING ON IN THIS
26 WORLD. AND I DO NOT PERSONALLY SUBSCRIBE TO A NEWSPAPER BECAUSE
27 AT MY WORK, THERE ARE PLENTY OF NEWSPAPERS AND MAGAZINES, AND I
28 USUALLY READ THE WALL STREET JOURNAL, FORTUNE MAGAZINE, AND

1 BUSINESS JOURNALS, AND I ALSO LIKE TO KEEP UP TO DATE WITH WHAT
2 IS GOING ON AROUND THE WORLD.

3 Q OKAY. HOW ABOUT TELEVISION OR THE MOVIES?

4 A TELEVISION AND THE MOVIES, I DO HAVE A TELEVISION, A
5 COLOR ONE.

6 (LAUGHTER.)

7 Q IN FACT, I EVEN THOUGHT I HEARD THAT YOU HAVE A VCR.

8 A YES, I DO.

9 Q OKAY.

10 A I SELDOM WATCH THEM BECAUSE IT'S JUST A MATTER OF TIME
11 CONSTRAINTS. THE THINGS I WATCH ARE MOSTLY DOCUMENTARY, THINGS
12 LIKE THAT.

13 Q OKAY. I HAVEN'T HEARD ANYTHING ABOUT THE MOVIES.

14 A I JUST DON'T HAVE ANY INTEREST FOR MOVIES. JUST A
15 PERSONAL PREFERENCE.

16 Q ALL RIGHT. NOW DO YOU REPRESENT -- WE HAVE HEARD ABOUT
17 THE NORTHERN PART OF THE UNITED STATES. NOW WE ARE DOWN IN
18 SOUTHERN CALIFORNIA.

19 DO YOU REPRESENT AN EXCEPTION DOWN THERE AS FAR AS PEOPLE
20 IN THE LOCAL CHURCH? IN OTHER WORDS, YOUR ACTIVITIES OF PLAYING
21 TENNIS AND READING THE WALL STREET JOURNAL AND HAVING A TELE-
22 VISION SET, IS THAT AN EXCEPTION DOWN THERE?

23 A WELL, MY ROOMMATE SUBSCRIBES TO WALL STREET JOURNAL.

24 Q AND IS YOUR ROOMMATE A MEMBER OF THE CHURCH?

25 A YES.

26 Q ALL RIGHT.

27 A AND AS FAR AS SPORTS ACTIVITIES IS CONCERNED, I DO RUN
28 WITH MY ONE ROOMMATE AND THE OTHER ROOMMATE WILL TRY TO GET HIM

1 TO RUN.

2 (LAUGHTER.)

3 Q HOW ABOUT OTHER PEOPLE YOUR AGE IN THE LOCAL CHURCH, DO
4 YOU KNOW WHAT THEIR ACTIVITIES ARE REGARDING THESE THINGS?

5 A IT IS QUITE DIVERSIFIED. SOME PEOPLE JUST, JUST THEIR
6 PERSONAL PREFERENCE, JUST DON'T LIKE ANY SPORTS AT ALL. SOME
7 LIKE TO, YOU KNOW, STUDY OR PLAY THE COMPUTER ALL DAY. THERE
8 ARE PEOPLE LIKE THAT. AND SOME PEOPLE ENJOY RUNNING, PLAYING
9 TENNIS, PLAYING BASKETBALL.

10 Q THEN WOULD YOU SAY THAT AT LEAST AS FAR AS THE YOUNG
11 PEOPLE THAT THE PREFERENCES DIFFER MUCH THE SAME AS IN ANY OTHER
12 GROUP?

13 A THAT'S RIGHT. JUST LIKE AMONG MY COLLEAGUES AT WORK;
14 SOME ENJOY SPORTS AND SOME JUST NEVER RUN, ONLY ENJOY EATING.

15 (LAUGHTER.)

16 Q ALL RIGHT. NOW, LET'S TALK A BIT ABOUT THE PRACTICES AT
17 THE CHURCH. FIRST, DO YOU FEEL THAT THERE IS ANY MIND MANIPU-
18 LATING GOING ON?

19 A ABSOLUTELY NOT.

20 Q ALL RIGHT. NOW OBVIOUSLY YOU WEREN'T SEDUCED INTO THE
21 CHURCH BECAUSE YOU WERE BORN INTO THE CHURCH, WEREN'T YOU?

22 A THAT'S RIGHT. BUT I HAVE TO SAY THIS, THAT I WENT TO A
23 CHRISTIAN AMERICAN ALLIANCE ELEMENTARY SCHOOL, AND MY PARENTS
24 DID NOT FORCE ME TO MAINTAIN OR STAY IN THE CHURCH.

25 Q SO THIS WAS YOUR OWN PREFERENCE, THEN. IS THAT WHAT YOU
26 ARE SAYING?

27 A THAT'S RIGHT. THAT'S RIGHT.

28 Q AT THE PRESENT TIME, DO YOU HAVE ANY FEAR, ARE YOU KEPT
