

1 Q OKAY. NOW DID THE MEMBERS OF YOUR CHURCH BECOME AWARE OF  
2 THE FACT THAT SON WAS IN ANOTHER CHURCH?

3 A OH, THEY KNEW THAT HE WAS FROM THE HAYWARD GROUP.

4 Q ALL RIGHT. FINE. HOW DID THEY KNOW THAT?

5 A WELL, THEY KNEW HOW I MET EVERYBODY, AND SO --

6 Q IN OTHER WORDS, YOU TOLD THEM?

7 A YES.

8 Q FINE.

9 A IN FACT, SOME OF THE PEOPLE FROM THE CHURCH HAD ATTENDED  
10 THE BIBLE STUDY.

11 Q ALL RIGHT. FINE. LET ME GO BACK. LET ME GO BACK.  
12 AGAIN, I'M READING ON PAGE 181 OF THE FOUR-WAY, AND IT READS AS  
13 FOLLOWS:

14 "SIX MONTHS AFTER SETTLING INTO HER NEW HOME,  
15 CIA HAD HER INITIAL CONTACT WITH THE LOCAL CHURCH.  
16 A PROSELYTER FOR THE LOCAL CHURCH, WHO NEVER IDENTI-  
17 FIED HIMSELF AS SUCH, WAS HIRED AS THE YOUTH DIRECTOR  
18 OF CIA'S SIXTEEN-MEMBER CHURCH YOUTH PROGRAM.  
19 FREQUENTING THE FAVORITE HANGOUTS OF THE CHURCH TEENS,  
20 THIS MAN EFFECTIVELY WON THE AFFECTION OF CIA AND HER  
21 FRIENDS THROUGH HIS WARMTH AND RAPPORT WITH THE HIGH  
22 SCHOOLERS. GRADUALLY, HE BEGAN TO INTRODUCE THE  
23 TEACHINGS OF LEE'S SENSUOUS THEOLOGY AND INVITED THE  
24 YOUTH GROUP TO ATTEND MEETINGS OF THE UNIDENTIFIED  
25 LOCAL CHURCH FELLOWSHIP IN THEIR AREA."

26 END OF THE PART I'M QUOTING. WAS THIS AN UNIDENTIFIED  
27 LOCAL CHURCH OR HAD YOU BEEN TOLD IT WAS THE CHURCH IN HAYWARD?

28 A YES, WE HAD BEEN TOLD.

1 Q ALL RIGHT. DID EVERYBODY KNOW THAT?

2 A YES.

3 Q OKAY. NOW WHEN IT SAYS, "SIX MONTHS AFTER SETTling" IN  
4 YOUR NEW HOME, THAT'S NOT TRUE EITHER. IT WAS WITHIN A MONTH  
5 AFTER YOU MOVED IN. IS THAT RIGHT?

6 A TRUE. YES.

7 Q ALL RIGHT. LET ME GO ON TO THE NEXT PARAGRAPH:

8 "CIA WAS CLASSICALLY EXPERIENCING THE INITIAL  
9 THREE STAGES OF THE SEDUCTION SYNDROME. THE TENSIONS  
10 OF ACCEPTING AND OVERCOMING HER DEBILITATING BACK-  
11 GROUND, COUPLED WITH THE PROSPECT OF ATTENDING  
12 COLLEGE IN THE NEAR FUTURE, CREATED A CHALLENGING  
13 TESTING GROUND FOR HER FAITH."

14 IS THAT A TRUE STATEMENT?

15 A NO, NOT IN THE LEAST.

16 Q OKAY. IT GOES ON:

17 "AS A CHRISTIAN, CIA WAS GROWING THROUGH HER  
18 QUALITY PRAYER TIMES AND BIBLE STUDIES. HER SIX  
19 MONTHS OF BOARDING WITH THE CARING CHRISTIAN FAMILY  
20 WERE MARKED BY LEARNING TO LOVE AND ACCEPT RESPONSIBI-  
21 BILITY, BUILDING TRUST AND ASSENTING TO CONSTRUCTIVE  
22 CRITICISM."

23 IS THAT A TRUE STATEMENT?

24 A NO.

25 Q WHY IS IT NOT TRUE?

26 A WELL, THE BOOK MAKES ME LOOK LIKE I WAS A NAIVE YOUNG  
27 TEENAGER, AND THE TRUTH WAS, I WAS A VERY RESPONSIBLE YOUNG  
28 ADULT BECAUSE OF THE FACT THAT MY MOTHER HAD DIED AND I HAD ALL

1 THESE RESPONSIBILITIES PRIOR TO EVER MOVING IN WITH THAT FAMILY.

2 Q OKAY.

3 A THE FACT, THE VERY FACT THAT I WAS SO, HAD SO MANY  
4 RESPONSIBILITIES IN THE CHURCH WOULD PRETTY MUCH BACK UP WHAT I  
5 JUST SAID.

6 Q THEN I'M SKIPPING A BIT AND I'M GOING TO GO OVER TO PAGE  
7 183 OF THE FOUR-WAY, THE DUDDY MANUSCRIPT, AND IT SAYS:

8 "INTO THIS FRAGILE PERIOD OF CIA'S LIFE WALKED  
9 THE LOCAL CHURCH REPRESENTATIVE WHOSE CONSTANT LOVE  
10 AND AFFIRMATION PRODUCED THE IMMEDIATE, POSITIVE  
11 EMOTIONAL FEEDBACK CIA REQUIRED."

12 IS THAT A TRUE STATEMENT?

13 A NO.

14 Q ALL RIGHT. GOING ON:

15 "NECESSARILY FOR A SEARCHING YOUTH, A LOVE BUILT  
16 ON GOOD TIMES ALONE MIGHT BE MORE APPEALING AND  
17 ENTICING THAN A LOVE THAT DEMANDS COMMITMENT AND  
18 RESPONSIBILITY."

19 NOW LET ME ASK YOU A QUESTION. WHEN YOU STARTED GOING TO  
20 THIS BIBLE STUDY WITH THE CHURCH IN HAYWARD, DID YOU UNDERSTAND  
21 THAT AS ONE THAT WAS JUST GOOD TIMES OR WAS THERE SOME REQUIRE-  
22 MENT AND RESPONSIBILITY BEING GIVEN AT THAT BIBLE STUDY?

23 A I WOULD SAY THAT THEY WERE THE MOST COMMITTED GROUP I HAD  
24 EVER BEEN TO.

25 Q ALL RIGHT. WELL, LET ME READ ON:

26 "LIKELIKE, THE EXCITEMENT OF LARGE GROUP FELLOW-  
27 SHIPS MIGHT BE MORE ATTRACTIVE THAN INDIVIDUAL BIBLE  
28 STUDY AND PRAYER TIMES."

1           NOW YOU HAVE TOLD US THAT WHAT YOU WERE GOING TO WAS  
2           BASICALLY A BIBLE STUDY. IS THAT RIGHT?

3           A           YES.

4           Q           AND WHAT WAS THE SIZE OF THE GROUP OF THIS CHURCH IN  
5           HAYWARD?

6           A           WELL, I BELIEVE AT THE BIBLE STUDY THE ATTENDANCE RANGED  
7           ANYTIME FROM, SAY, TWELVE TO THIRTY.

8           Q           OKAY.

9           A           THERE WAS A WIDE RANGE, DEPENDING ON IF PEOPLE COULD MAKE  
10          IT OR NOT.

11          Q           ALL RIGHT. I WANT TO GO ON:

12                    "FOR PEOPLE (THIS IS AGAIN FROM THE DUDDY MANU-  
13                    SCRIPT)." "FOR PEOPLE WHO ARE EXPERIENCING TENSION,  
14                    SEEKING RESOLUTIONS AND AT TURNING POINTS OF TRANSI-  
15                    TION, IMMEDIATE RESULTS AND RESOLUTIONS ARE SEIZED  
16                    QUICKLY. THUS, CIA'S OUTSTRETECHED HAND WAS OPEN  
17                    TO THE LOCAL CHURCH MAN WHO WARMLY CLASPED IT,  
18                    TUGGED GENTLY, THEN PULLED HARD."

19                    (LAUGHTER.)

20          Q           (CONTINUING) DOES THAT REPRESENT WHAT TOOK PLACE?

21          A           NO, NOT IN THE LEAST

22          Q           (READING):

23                    "TAKE A MOMENT TO PICTURE THE SCENARIO. THE YOUTH  
24                    DIRECTOR SOLVED PROBLEMS RELIGIOUSLY. SO DID CIA.  
25                    DISCERNING THAT CIA WAS IN THE SEDUCTION SYNDROME,  
26                    HE OFFERED PROMPT SHORT-TERM RESOLUTIONS TO EASE THE  
27                    TENSION POINTS SHE WAS EXPERIENCING. CIA CRAVED  
28                    RELATIONSHIPS THAT WERE SYMBOLIZED BY UNBROKEN UNITY

1 AND WARM AFFIRMATION. THE LOCAL CHURCH SERVED AS A  
2 BEACON OF CONFORMITY; CIA HERSELF COMMENTING ON THE  
3 ABSENCE OF DISAGREEMENT AND ENCOURAGEMENT TOWARD  
4 INDEPENDENT, RESPONSIBLE THINKING OR ACTIONS."

5 NOW FIRST, WERE YOU EXPERIENCING TENSIONS AT THAT TIME?

6 A NOT ANY MORE TENSIONS THAN ANYONE EVER EXPERIENCES AT ANY  
7 TIME IN THEIR LIFE.

8 Q THERE WERE NO MAJOR CRISES IN YOUR LIFE AT THAT TIME?

9 A NO. ACTUALLY IT WAS GOING VERY WELL.

10 Q AND ABOUT THAT TIME, WERE YOU ALSO ENGAGED OR DID YOU  
11 BECOME ENGAGED DURING THAT PERIOD OF TIME?

12 A REALLY, I WASN'T. DURING THAT PERIOD OF TIME, I WASN'T  
13 ENGAGED.

14 Q OKAY. BUT DID YOU HAVE A BOYFRIEND?

15 A YES, WITH WHOM I BECAME ENGAGED SOON AFTER.

16 Q AND THEN ULTIMATELY MARRIED?

17 A RIGHT.

18 Q I'M GOING TO SKIP A LITTLE BIT HERE. BUT (READING):

19 "HOURS OF GROUP PRAY-READING AND CALLING ON THE  
20 NAME OF THE LORD SEEMED TO ALLEVIATE HER TENSIONS  
21 IN A WARM INVITING WAY."

22 WAS THAT TRUE?

23 A NO.

24 Q ALL RIGHT. TELL THE COURT WHAT YOUR REACTION WAS TO THE  
25 PRAY-READING AND THE CALLING ON THE NAME OF THE LORD.

26 THE COURT: EXCUSE ME, WAS THIS PRAY-READING DONE DURING  
27 BIBLE STUDYING, READING CLASSES, OR DID YOU GO TO SOME OF THE  
28 SESSIONS OF THE LOCAL CHURCH, THEIR MEETINGS?
