

1 Q NUMBER TEN: "WERE YOU EVER ENCOURAGED TO BEHAVE  
2 UNETHICALLY BY CHURCH LEADERS? TO LIE? TO DECEIVE?"

3 A NONE OF THE PRESENT MEMBERS, NONE OF THE EX-MEMBERS, AND  
4 NONE OF THE METHODISTS REPORTED SUCH.

5 Q AND THIS, OF COURSE, GOES TO THE TEACHING THAT HE IS  
6 ADVOCATING IMMORALITY?

7 THE COURT: ONE OF THE AVERSIONS IN THE MANUSCRIPT?

8 MR. MORGAN: THAT'S RIGHT.

9 A I GOT SOME STRONG REACTIONS COUNTER TO THIS, SAYING QUITE  
10 THE REVERSE. "WE WERE ALWAYS ENCOURAGED TO BEHAVE ETHICALLY."

11 Q (BY MR. MORGAN) AND WOULD THAT BE ALSO FROM THE  
12 EX-MEMBERS?

13 A YES. THE FACT IS THAT I REMEMBER THAT STRONGEST FROM ONE  
14 OF THE EX-MEMBERS.

15 DID YOU MEAN TO SKIP NUMBER NINE?

16 Q OH, NO. I'M SORRY. LET'S TAKE NUMBER NINE: "WERE YOU  
17 EVER CHASTISED PUBLICLY BY CHURCH LEADERS?"

18 A NO ONE OF THE PRESENT MEMBERS, NONE OF THE EX-MEMBERS,  
19 NONE OF THE METHODISTS WERE CHASTISED PUBLICLY.

20 Q NUMBER ELEVEN: "WAS THE CHURCH MISREPRESENTED TO YOU?  
21 DID YOU KNOW AND UNDERSTAND WHAT YOU WERE GETTING INTO?"

22 A THIS QUESTION, AS YOU CAN REALIZE, WAS A NO-YES QUESTION.

23 Q ALL RIGHT.

24 A "WAS THE CHURCH MISREPRESENTED?" NO ONE OF THE PRESENT  
25 MEMBERS, NONE OF THE EX-MEMBERS, AND NONE OF THE METHODISTS  
26 REPORTED THE CHURCH BEING MISREPRESENTED TO THEM. THAT GOES TO  
27 THE SEDUCTION ISSUE, DEVIANT MOTIVE, THOUGHT YOU WERE GETTING  
28 ONE THING AND GOT ANOTHER.

1 Q THAT'S THE "SEDUCTION SYNDROME" MR. DUDDY CREATED?

2 A YES.

3 Q AND THE ANSWERS THERE SHOW IT WAS TOTALLY FALSE?

4 A YES.

5 Q HOW ABOUT THE SECOND PHASE OF THE QUESTION?

6 A IT REVERSED. ALL OF THE PRESENT MEMBERS, ALL OF THE  
7 EX-MEMBERS, AND ALL OF THE METHODISTS REPORTED THEY KNEW WHAT  
8 THEY WERE GETTING INTO.

9 Q WAS THAT OF SOME SIGNIFICANCE TO YOU?

10 A THAT WAS TWO SIDES OF THE SAME QUESTION.

11 Q FINE. LET'S GO TO NUMBER TWELVE: "AS A RESULT OF CHURCH  
12 WORSHIP, DID YOU EVER GO INTO A TRANCE? DID YOU FEEL SPACEY?  
13 CONFUSED? OUT OF CONTROL? HYPNOTIZED?"

14 NOW FIRST, CAN YOU EXPLAIN TO HIS HONOR WHY THIS QUESTION  
15 IS BEING ASKED?

16 A WELL, THE BOOK TALKED ABOUT ALTERED STATES OF CONSCIOUS-  
17 NESS AS IF THE CHURCH MEETINGS, WHICH WERE BASICALLY OF TWO OR  
18 THREE TYPES -- ONE IS THE TRAINING SESSION, LED BY WITNESS LEE,  
19 THAT WILL BEGIN OR END WITH A TESTING WHERE PEOPLE STAND UP AND  
20 HE ASKS THEM QUESTIONS AND THEY -- OR THEY VOLUNTEER; ANOTHER IS  
21 A REGULAR SUNDAY MORNING LED BY THE ELDERS; AND THE THIRD WOULD  
22 BE THE PRAY READING SESSIONS WHICH OCCUR MIDWEEK OR ON SATURDAY,  
23 I'M UNCLEAR, AND THEY ASKED ME WHAT DID I MEAN, AND I MENTIONED  
24 ALL THREE OF THOSE.

25 IS THAT THE QUESTION YOU ASKED ME?

26 Q YES. NO, BUT NOW MY QUESTION IS, WHY ARE YOU ASKING  
27 THIS QUESTION?

28 A BECAUSE THE INFERENCES, IF NOT THE OUTRIGHT ACCUSATION
