

1 BEING REPEATED IN ANY, YOU KNOW, REPETITIVE WAY BY ANY MEANS.  
2 I'VE TALKED TO SOME OTHER FOLKS, AND I GATHER THAT THAT'S A  
3 VERY -- I WAS IN ON A VERY PARTICULAR CAPITAL EXPERIENCE.

4 Q OKAY. LET'S GO TO THE NEXT QUESTION, NUMBER FOURTEEN.

5 A THIRTEEN.

6 Q THIRTEEN: "AS A RESULT OF CHURCH WORSHIP, DID YOU EVER  
7 FEEL LIKE YOU HAD TO OBEY THE LEADERS WITHOUT THINKING THINGS  
8 THROUGH ON YOUR OWN?"

9 A NONE OF THE PRESENT MEMBERS, TWO OF THE EX-MEMBERS, TWO  
10 OUT OF THIRTEEN, AND NONE OF THE METHODISTS FELT THAT WAY.

11 Q AND WHAT DID THAT, THOSE FIGURES, INDICATE TO YOU?

12 A CHANCE VARIATION, NO DIFFERENCE BETWEEN GROUPS. I THINK  
13 THAT PARTICULAR QUESTION WAS DIRECTED TOWARD THE PRESUMPTION  
14 THAT UNDER A TRANCE STATE, AS IN TWELVE, OR UNDER A HYPNOTIC  
15 STATE A PERSON MIGHT BE TOLD SOMETHING TO DO AND DO IT WITHOUT--  
16 DO IT KIND OF AS AN AUTOMATON OR ZOMBIE, WITHOUT THINKING IT  
17 THROUGH. IT ALSO PRESUMES, I THINK THE BOOK DOES, THAT WHAT THE  
18 PERSONS ARE TOLD TO DO WILL BE EVIL.

19 Q THE TWO THAT SAID "YES" TO THAT, DID THEY GIVE ANY  
20 COMMENTS?

21 A THEY QUALIFIED IT AND SAID THAT THEY TOOK IT MORE TO BE  
22 THE GROUP EXHILIRATION, THE PRESSURE OF THE GROUP EXPERIENCE.

23 Q NUMBER FOURTEEN: "DO YOU STUDY THE BIBLE ON YOUR OWN?  
24 WHAT BIBLE HELPS DO YOU USE IN YOUR STUDY?"

25 FIRST, CAN YOU TELL THE COURT WHY THIS QUESTION WAS  
26 ASKED?

27 A IT HAD TO DO WITH THE ACCUSATIONS THAT ALL -- THAT THE  
28 PEOPLE WERE TOLD ENTIRELY HOW TO STUDY THE BIBLE AND THAT THEY
