

1 IS QUOTED AS SAYING LOVE AND DO WHATEVER YOU WANT.

2 THE COURT: I SUPPOSE THAT'S TRUE.

3 Q (BY MR. MORGAN) DID YOU FIND IN YOUR READINGS THAT MR.  
4 DUDDY TOOK THESE STATEMENTS OUT OF CONTEXT?

5 A NOT ONLY OUT OF CONTEXT. I GET THE IMPRESSION THEY  
6 WERE TWISTED AROUND TO MEAN WHAT HE WANTED THEM TO MEAN.

7 Q AND THEN ARE YOU SAYING THAT THIS ISN'T SOMETHING THAT  
8 WAS DONE INADVERTENTLY, THIS WAS DONE DELIBERATELY?

9 A AGAIN, I AM NOT VERY GOOD -- I DON'T LIKE JUDGING  
10 PEOPLE BUT I CANNOT HONESTLY SEE HOW THIS COULD HAVE BEEN A  
11 GENUINE INNOCENT MISTAKE.

12 Q LET ME ASK YOU TO GO TO PAGE 123 AND IT WOULD BE THE  
13 FIRST THREE PARAGRAPHS THERE AT THE TOP OF THE PAGE. I WILL  
14 ASK YOU TO READ THEM TO YOURSELF AND THEN I WILL ASK YOU SOME  
15 QUESTIONS ABOUT IT.

16 AGAIN, CAN YOU TELL THE COURT WHAT YOU UNDERSTAND MR.  
17 DUDDY IS ATTEMPTING TO CONVEY TO THE READER?

18 A OKAY, THIS TALKS ABOUT AUTHORITY IN THE CHURCH, AND THE  
19 IDEA HERE IS THAT THIS IS A VERY AUTHORITARIAN GROUP WHERE  
20 WITNESS LEE RULES MORE OR LESS LIKE A DESPOT AND WHERE THE  
21 ELDERS ARE MORE OR LESS LITTLE DESPOTS IN THEIR OWN LITTLE  
22 FIELDS AND THEY CONTROL EVERYTHING AND YOU ARE JUST MERELY  
23 SUBMISSIVE TO THEM.

24 Q DOESN'T HE QUOTE WITNESS LEE THERE IN THE MIDDLE  
25 PARAGRAPH THAT YOU SHOULD NOT FREELY CRITICIZE AND SO ON?

26 A YES, HE DOES.

27 Q AGAIN, DOES THAT FAIRLY REPRESENT WITNESS LEE'S  
28 TEACHINGS?

1 A NO, I DON'T THINK SO. AGAIN, I AM MAKING A -- WE ARE  
2 NOT ENCOURAGED TO CRITICIZE THE POPE AND IT IS NOT AN  
3 IMPOSITION FOR US. WE DON'T FEEL IT THAT WAY. AND NOBODY  
4 WOULD CONCLUDE -- I WOULDN'T CONCLUDE THAT THE POPE IS MY  
5 DICTATOR SO I THINK HE IS TALKING HERE OF THE WAY PEOPLE  
6 SHOULD RELATE WITHIN THE SAME COMMUNITY, AND WITHIN A  
7 COMMUNITY THE BEST RELATIONSHIP IS NOT ONE OF CONFRONTATION  
8 AND CRITIC BUT ACTUALLY DIALOGUE AND EXCHANGING VIEWS AND  
9 POINTING OUT MATTERS WITHOUT A PUBLIC DEBATE, WHICH I THINK  
10 IS THE CORRECT WAY TO DO IT.

11 Q AND DID YOU UNDERSTAND THAT THAT IS THE WAY WITNESS  
12 LEE TEACHES IT?

13 A THAT IS MY IMPRESSION.

14 Q HERE MR. DUDDY HAS PUT IT IN THERE TO MAKE IT APPEAR  
15 THAT WITNESS LEE IS SAYING YOU DON'T ARGUE WITH THE ELDERS.

16 A YEAH. I REMEMBER AN INCIDENT AT ONE OF THE MEETINGS I  
17 ATTENDED AND ONE WAS -- ONE OF THE ELDERS AT THE END OF THE  
18 SERVICE WAS ENCOURAGING PEOPLE TO GO TO A REGIONAL MEETING.  
19 HE WAS ENCOURAGING THEM WITHOUT AN IMPOSITION THAT I CAN TELL  
20 YOU.

21 Q IN YOUR VISITS TO THE LOCAL CHURCH HAVE YOU OBSERVED ANY  
22 CONDUCT THAT WOULD APPEAR TO BE THAT OF AUTOCRATIC RULE  
23 OR DESPOTS OR ANYTHING OF THAT SORT?

24 A NO, AND I HAVE BEEN TRAINED TO OBSERVE ALL THAT STUFF  
25 BECAUSE THEY TEACH IN ANTHROPOLOGY USE YOUR EYES AND EARS  
26 LIKE ANTENNA. YOU ARE WATCHING EVERYTHING YOU SEE SO I WAS  
27 WATCHING THE MOOD OF THE PEOPLE. I WAS WATCHING HOW THEY  
28 WERE RELATING TO EACH OTHER. I WAS NOTICING EVERYTHING. I
