3 IT'S BEEN MY EXPERIENCE THAT MOST PEOPLE DO NOT CHECK  
4 FOOTNOTES.

5 THE COURT: IN YOUR EXPERIENCE AND IN GOING  
6 THROUGH ALL THIS MATERIAL AND BACKGROUND AND SO FORTH AND  
7 DOING THE STUDYING, HAVE YOU BEEN ABLE TO FIND ANYTHING  
8 THAT WOULD GIVE YOU A JUSTIFICATION OF WHY MR. DUDDY WOULD  
9 HAVE DONE THIS?

10 MR. MORGAN: COULD I AMEND THE WORD FROM  
11 "JUSTIFICATION" TO "REASON"?

12 THE COURT: REASON. IF I WERE TO GO FOR THAT,  
13 WHY WOULD A MAN LIKE MR. DUDDY DO THIS? WAS THERE ANYTHING  
14 YOU FOUND THAT THERE WAS SOME BREAK OR THERE WAS SOME  
15 FRICTION, THERE WAS SOME PROBLEM THAT OCCURRED BETWEEN THE  
16 LOCAL CHURCH, WITNESS LEE AND EVERYTHING --

17 THE WITNESS: AT ONE POINT EARLY IN THEIR LIFE  
18 THE WORLD CHRISTIAN LIBERATION FRONT AND THE LOCAL CHURCH  
19 HAD THEIR HEADQUARTERS IN BERKELEY RIGHT ACROSS THE STREET  
20 FROM EACH OTHER AND THERE WERE SEVERAL INCIDENTS OF PERSONAL  
21 CONFRONTATIONS.

22 THERE WAS ALSO AN INCIDENT IN DALLAS IN LATER YEARS  
23 SHORTLY BEFORE, AS I UNDERSTAND IT, GOD-MEN I APPEARED OR  
24 SOMEWHERE RIGHT IN THERE IN WHICH THERE WAS SOME PERSONAL  
25 CONFRONTATION AND IN WHICH THE SCP CAME OUT SECOND BEST.

26 EVERY PIECE OF LITERATURE I HAVE BEEN ABLE TO FIND  
27 ON THE LOCAL CHURCH -- AND MY LIBRARY IS GROWING ALL THE  
28 TIME -- CAN BE TRACED TO THAT ONE INCIDENT -- OR TO THE

1 CONFRONTATIONS IN BERKELEY.

2 JACK SPARKS' BOOK, THE MATERIAL THE SCP PUT OUT AND A  
3 NUMBER OF ITEMS DERIVATIVE OF SCP MATERIAL. I DON'T KNOW  
4 WHAT HAPPENED. BUT THAT'S THE BEST I CAN MAKE OF IT.

5 THE COURT: BY THE WAY, WE WERE TALKING EARLIER  
6 ABOUT THE STIGMA OF BEING ASSOCIATED IN THE EVANGELICAL  
7 MOVEMENT OF BEING IN A CULT. DO YOU REMEMBER THE TIME  
8 MC CARTHYISM WAS GOING ON AND ABOUT THE COMMUNISM, AND EVEN  
9 THOUGH YOU COULD PROVE YOU ARE NOT A COMMUNIST, YOU STILL  
10 HAD THE SAME STIGMA.

11 THE WITNESS: SOME OF MY EARLIEST MEMORIES ARE  
12 WATCHING THE MC CARTHY HEARINGS.

13 THE COURT: MINE TOO. DO YOU FEEL THERE IS THAT  
14 SAME STIGMA THAT ONCE ACCUSED THERE IS SOMETHING REMAINS?

15 THE WITNESS: I THINK I HAVE IN PRINT ON MORE  
16 THAN ONE OCCASION SAID THAT TO CALL SOMEONE A CULT IS THE  
17 1970'S EQUIVALENT OF LABELING THEM A PINKO.

18 Q (BY MR. MORGAN) LET ME ASK YOU THIS, SIR. FIRST,  
19 HOW MANY EVANGELICALS WOULD THERE BE IN THE UNITED STATES?

20 A FORTY MILLION IS THE USUAL COUNT.

21 Q AS A CHRISTIAN AND AS AN EVANGELICAL, ARE YOU  
22 CONCERNED ABOUT THIS BOOK?

23 A VERY MUCH SO.

24 Q IN WHAT RESPECT?

25 A AS AN EVANGELICAL I AM VERY MUCH CONCERNED ABOUT  
26 ISSUES OF TRUTH, AND WHILE I AM CONCERNED THAT AS AN  
27 EVANGELICAL OUR POSITION IS CLEARLY STATED AND DIFFERENTIATED  
28 FROM THOSE WHO DISAGREE WITH US. I FEEL THAT IN THIS CASE WE
