

1 NOT JUST PUTTING ASIDE -- IT IS DOWNGRADING ALL OF  
2 SCRIPTURE.

3 Q (BY MR. MORGAN) THEN DOES MR. DUDDY WORK THIS  
4 ULTIMATELY INTO HIS BOOK TO CREATE AN IDEA THAT BECAUSE OF  
5 THIS WITNESS LEE SOMEHOW ENCOURAGES IMMORALITY?

6 A THAT IS WHERE THIS IS LEADING. IF THE BIBLE AND  
7 PARTICULARLY THE LEGAL PARTS OF THE BIBLE HAVE BEEN PUT  
8 ASIDE, THEN THEY ARE NO -- THEY NO LONGER HAVE TO BE  
9 FOLLOWED, THAT DUDDY HAS CREATED THE IMAGE THAT WITNESS LEE  
10 IS TEACHING A SPIRITUALIZED THEOLOGY, WHERE THE ONLY THING  
11 THAT IS IMPORTANT IS YOUR RELATIONSHIP SPIRITUALLY TO GOD  
12 AND THAT THE MORAL CODE HAS BEEN SET ASIDE SO THAT YOU ARE  
13 FREE TO DO VARIOUS IMMORAL THINGS.

14 IN ACTUAL FACT, OVER AND OVER AGAIN IN HIS WRITINGS,  
15 LEE SAYS THAT THE TEN COMMANDMENTS ARE FOR ALL TIMES AND ALL  
16 PLACES AND ALL PEOPLE, AND HE HAS ONE RATHER HUMOROUS ITEM  
17 WHERE HE SAYS -- HE IS TALKING ABOUT PRAYER AND SEEKING  
18 PERSONAL GUIDANCE THROUGH PRAYER, AND HE SAYS YOU DON'T GO  
19 TO GOD AND PRAY "GOD, SHOULD I STEAL" AND SEEK GUIDANCE ON  
20 THAT MATTER.

21 HE SAYS, NO, THE LAW HAS BEEN GIVEN, IT SAYS DON'T  
22 STEAL. THAT IS IT. YOU DON'T EVEN ASK GOD ABOUT THAT BECAUSE  
23 GOD HAS ALREADY SPOKEN ON THAT ISSUE.

24 IN ANOTHER PLACE WHERE HE IS DISCUSSING CHRIST TALKING  
25 ABOUT FULFILLING THE LAW HE SAYS WHY DID THE TEN COMMANDMENTS  
26 HAVE TO BE FULFILLED IN CHRIST? SAID BECAUSE THEY WERE  
27 INCOMPLETE, THAT THE TEN COMMANDMENTS SAID DON'T MURDER.  
28 THAT MEANS DON'T MURDER. IT DIDN'T SAY ANYTHING ABOUT ANGER.

1 YOU CAN GET ANGRY -- MOSES DIDN'T HAVE ANYTHING AGAINST YOU.  
2 CHRIST SAID NOW YOU CAN'T EVEN GET ANGRY.

3 THAT IS LAW. YOU'VE GOT TO FOLLOW THAT. IS FOR  
4 ALL TIMES, ALL PLACES, ALL PEOPLE.

5 Q LET ME ASK YOU TO TURN TO PAGE 73 OF THIS FOUR-WAY  
6 AND UP AT THE FIRST FULL PARAGRAPH WHERE IT SAYS "CONSISTENTLY  
7 LEE'S COUNSEL STEERS PARISHIONERS AWAY FROM BIBLICAL ETHIC  
8 REGARDING BEHAVIOR AND TEACHINGS WHICH ENCOURAGE RESPONSI-  
9 BILITY AND AFFIRMATIVE ACTION." AGAIN, THAT IS THE END OF  
10 THE PART I AM QUOTING. IS THIS AGAIN WHERE MR. DUDDY IS  
11 CONVEYING THE IDEA THAT WITNESS LEE'S TEACHINGS ARE LEADING  
12 TOWARDS IMMORALITY?

13 A THAT IS THE EXACT POINT HE IS MAKING, THAT LEE DIS-  
14 COUNTS FOLLOWING MORAL LAW AND THEREFORE BREAKING MORAL LAW  
15 IS OKAY FOR A MEMBER OF THE LOCAL CHURCH.

16 THAT IS JUST TOTALLY THE OPPOSITE OF WHAT LEE  
17 CONSISTENTLY TEACHES THROUGH HIS BOOKS.

18 Q WE HAVE ON THE BOARD HERE PAGES 150 AND 155 FROM  
19 CHRIST VERSUS RELIGION, THE VERY SAME ONE THAT WE HAVE BEEN  
20 DOING, AND WITNESS LEE SAYS "I DO HAVE SCRIPTURAL GROUND TO  
21 SAY THAT WHAT WE NEED IS SOMETHING IN THE SPIRIT, NOT  
22 ANYTHING MERELY IN THE LETTER, ACCORDING TO THE WRITTEN  
23 SCRIPTURES. WHO CAN ARGUE? PLEASE DO NOT UNDERSTAND ME --"

24 THE COURT: MISUNDERSTAND.

25 MR. MORGAN: MISUNDERSTAND. THANK YOU, YOUR  
26 HONOR. "PLEASE DO NOT MISUNDERSTAND ME. I AM NOT SAYING  
27 NOR HAVE I EVER SAID THAT WE SHOULD NOT CARE FOR THE  
28 SCRIPTURES." HE IS SAYING THAT THE SCRIPTURES ARE UP THERE,
