

1 DEFINITELY DISCOURAGED.

2 Q OKAY. DO YOU HAVE ANY UNDERSTANDING THAT THE TEACHING  
3 SAYS YOU SHOULD LIVE A HIGHER LIFE THAN PERHAPS EVEN THE TEN  
4 COMMANDMENTS?

5 A YES.

6 Q TO THE BEST OF YOUR AWARENESS, IS THAT SOMETHING THAT'S  
7 PASSED ON TO THESE TWO-HUNDRED CHILDREN IN THAT CHURCH?

8 A YES, IT IS.

9 Q ALL RIGHT. CAN YOU TELL THE COURT SOMETHING ABOUT --  
10 EXCUSE ME. DO YOU HOLD ANY POSITION IN THE CHURCH?

11 A NO, I DO NOT.

12 Q IN OTHER WORDS, YOU ARE JUST BASICALLY A MEMBER. RIGHT?

13 A RIGHT.

14 Q WHEN YOU GO TO THE, SAY, PRAY-READING, DO YOU PARTICIPATE  
15 IN THAT?

16 A YES.

17 Q DO YOU GET UP AND SPEAK WHEN THERE IS TIME, WHEN THE  
18 MEMBERS SPEAK?

19 A YES, I DO.

20 Q ALL RIGHT. ANOTHER QUESTION. ARE YOU FAIRLY ACTIVE IN  
21 YOUR PROFESSION? IN OTHER WORDS, DO YOU FEEL SOMEHOW YOU ARE  
22 ISOLATED FROM THE REST OF THE PROFESSION?

23 A OH, NO. NO. I'M VERY ACTIVE IN THE PROFESSION.

24 Q DO YOU FEEL THAT YOU ARE IN ANY WAY ISOLATED FROM SOCIETY  
25 ITSELF BY BEING IN THE LOCAL CHURCH?

26 A NO, I, I INTERACT WITH SOCIETY OF COURSE ALL THE TIME.  
27 I SEE MULTIPLE PEOPLE EVERY DAY AND OF COURSE WORKING AROUND A  
28 LOT OF HEALTH-RELATED PROFESSIONALS, NURSES, OTHER PHYSICIANS,

1 RECEPTIONISTS, EVERYBODY, I DON'T FEEL ISOLATED AT ALL.

2 Q WHEN YOU ARE ATTENDING THE CHURCH, DO YOU HAVE ANY FEELING  
3 THAT YOU DARE NOT AND CANNOT AT ANY TIME CRITICIZE AN ELDER IF  
4 YOU THINK THE ELDER IS WRONG?

5 A NO, I DON'T HAVE A FEELING THAT I COULD NOT CRITICIZE AN  
6 ELDER.

7 Q ARE YOU AWARE OF ANY TEACHINGS, I MEAN DO ANY TEACHINGS  
8 EXIST THAT SAY YOU CAN'T DO THAT?

9 A NO.

10 Q HAVE YOU BEEN PRESENT WHEN WITNESS LEE HAS GIVEN MESSAGES?

11 A OH, YES.

12 Q AND PERHAPS FOR THE BENEFIT OF THE COURT, WHAT MAYBE SOME  
13 CHURCHES MIGHT CALL A SERMON, IS THAT CALLED A MESSAGE IN THE  
14 LOCAL CHURCH?

15 A YES.

16 Q HAVE YOU EVER OBSERVED WITNESS LEE TO SORT OF SINGLE OUT  
17 OR PICK SOMEBODY OUT AND THEN HUMILIATE THEM IN FRONT OF THE  
18 OTHERS?

19 A I HAVE NEVER OBSERVED THAT.

20 Q WILL YOU TELL THE COURT GENERALLY WHAT YOUR OBSERVATIONS  
21 ARE AS FAR AS WITNESS LEE'S DEemeanOR WHEN HE IS SPEAKING IN  
22 FRONT OF THE MEMBERS OF THE CHURCH?

23 A HIS DEemeanOR IS THAT OF ONE WHO IS VERY SERIOUS IN REGARD  
24 TO THE WORD THAT HE IS SHARING WITH THE PEOPLE, AND AT TIMES CAN  
25 BE VERY HUMOROUS, BUT MANY TIMES IS VERY SERIOUS REGARDING THE  
26 WORD THAT HE IS SHARING.

27 Q OKAY. ARE YOU AWARE, EITHER AS A MEMBER OR AS A DOCTOR,  
28 OF ANY PERSON BEING HOSPITALIZED BECAUSE OF EITHER CONDUCT BY
